

# **Wing Beer Specials Burger Dog Eating Competition Rules & Waiver of Liability Form**

## **1. ELIGIBILITY:**

- Open to participants 19 years or older.

## **2. CONTEST RULES:**

- Participants must sign and complete all necessary documents, including Contest Rules, Liability Waiver, and Photo Release.
- Contestants must be 19+ and eligible to participate.
- The object is to be the first person to eat 1 Burger Dog within 5 minutes. If time runs out, the winner will be determined by who has eaten the most of their Burger Dog within the 5 minutes.
- Contestants may eat sitting or standing, using hands only.
- Only water may be consumed during the competition.
- The Burger Dog must be fully chewed and swallowed.
- Throwing up results in automatic disqualification.
- The judge has final say in any disputes, including whether a Burger Dog is fully eaten.

## **3. GROUNDS FOR DISQUALIFICATION:**

- False or incomplete entry or waiver forms.
- Starting before the official start signal.
- Throwing up, swearing, spitting, or other unacceptable behavior.
- Interfering with other contestants or causing property damage.
- Any action deemed unsportsmanlike or unsafe by the event organizers.
- Use of any substances, including alcohol, before or during the event.

## **4. PRIZING & AWARDS:**

- The winner receives a \$50 gift card for the Regency Athletic Resort restaurant, a Wing Beer Specials Championship shirt, and two stainless steel Chicken Dippin dippers.
- The winner also earns bragging rights as the official Wing Eating Champion.
